Bitnomial Exchange, LLC (“Bitnomial” or the “Exchange”) hereby submits for self-certification to the Commodity Futures Trading Commission (the “Commission” or “CFTC”), under Commission regulation 40.6(a), updates to Bitnomial’s fees. These updates will become effective on January 21, 2026.

Exchange fees will be reduced from \$2.00 to \$0.02 on the following contracts:
